High Plains ASC, the Show Secretary and Club Membership assume no responsibility for any loss, damage or injury sustained by an exhibitor, handler, dog, property, children or spectator. All dogs must be crated or leashed except while competing.

- Entry Fees will not be returned if the show cannot be opened or be completed due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of High Plains ASC. 
