But What Time Will My Class Start?

We get a lot of questions on "when will my class start" for trials. We cannot give out times other than the start of the first class of the day. However, here is a way for you to estimate when your class MAY start running:

Page 9 of the BHA rulebook gives an estimate for judging time per run, per class (www.BarnHunt.com under "Rules & Resources")

Above, we give entry counts as of the pre-entry closing along with the order the classes will run.

You can multiply out the estimated judging time per run x the entries in each class to get a rough estimate. However, please note that this doesn't include absent dogs, move-ups, day-of-show/late entries, etc. And runs don't always last the "estimated" judging time per run. There are no refunds/credits/moves for missed runs. Calculate at your own risk!

Late/Day of Show Entries:

Please check the event page on the Matrix Dog website for the most recent info. Please note that these counts are only current as of the date/time listed on the page. Available entries are first come first serve and subject to change at any time. **They must be submitted at least 30 minutes prior to the morning briefing and are NOT guaranteed!**

Move-Ups:

Move-ups are not available same-day due to the running order. You can move up the following day though! See the trial secretary for more information.

RV Parking:

Miscellaneous Notes:

The building is cooled and heated, but please feel free to bring **fans** and **extension cords**, etc.

Water is available in the bathrooms but if you can please bring water jugs for dog water.

X-Pens are NOT allowed due to the matting. All **crates** must have a towel/tarp/blanket between them and the matting. (It's expensive flooring!)

Crating space will be tight. Please pack light. RMR reserves the right to limit individual crating space. You are welcome to bring **chairs** but please remember to protect the matting!

Dogs must be kept on lead in keeping with the leash laws. Please also remember that this is a shared warehouse and to respect other people's property!

Per Barn Hunt Association rules: Dogs that are loud and disruptive may be asked to be located away from the rings/crating area.

Potting: There are some grass/mulch areas/fields outside the building. Please be sure to pick up after your dog. Please keep your dog from peeing on the side of the building, or on any items that people have to pick up! Please clean up any accidents in the building immediately.

Food/Drinks: There are lots of shops in the new complex including Silver Mine Subs and a King Soopers! **We will also have lunch and snacks on site, available for a donation!**

Bathrooms: There are two bathrooms on site.
