Move Ups between trials (same day and next day) WILL be offered. Move ups for the next trial must in writing to the Trial Secretary no later than 30 minutes after the last dog finishes that trial.

HANDLER DISCRIMINATION DIVISON

Handler Discrimination classes are titling classes in which the targeted scent is that of the handler themselves. Handlers are required to provide their own scented articles in a plastic bag, for the Novice class, one cotton glove or cotton sock, for Advanced, Excellent, and Master, cotton balls or cotton swabs. Three qualifying scores are required to earn titles in each class. Handlers may utilize any method they feel is best to **scent their article**. Suggestions include rubbing the article on the handler's body or storing the item in dirty laundry.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

ENTRY FEES

*an entry is defined as a single run by a single dog, in a single class. Entry fees include a \$3.50 per run AKC recording fee.

First entry*\$25

Additional entries* in the same trial.....\$20

Late Entry (after March 2, 2020) and Day-Of-Show Entries add \$5 to each entry (\$30 first entry and \$25 each additional entry in the same trial).

WAIT LIST INFORMATION

FRONT RANGE SCENT WORK CLUB is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of **50 entries per day** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to **March 2, 2020 at 11:59pm MST**. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund. On event day, if there are absent handlers declared prior to the start of the trial, waitlisted entries present can be taken to fill those spots. If the wait list is expired, any teams present may be allowed to fill those slots.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include crating, warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. **NO DOGS** are to be present during the Handler's Briefing.

A **warm-up area** will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blanks containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run, or for recovery after the run. The warm-up area is not for training or relieving of the dog.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 26 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be ask to leave the area by the judge. Spectators are forbidden to discuss details of the search until the completion of the class.

Indoor crating space may be available on a limited basis, depending on the weather. The event site will require a tarp to be placed on the floor underneath your crates. Crates may be left overnight; however, the **FRONT RANGE SCENT WORK CLUB** and the **ADAMS COUNTY FAIRGROUNDS** will not be responsible for any lost or damaged items left at the show site.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

First Place.....*Blue*
Second Place.....*Red*
Third Place.....*Yellow*
Fourth Place.....*White*
Qualifying Score.....*Dark Green*

A **New Title rosette** will be awarded to all dog and handler teams finishing a title.

High in Trial

Teams who participate in the same difficulty level in all elements offered, and qualify in each, are eligible to win High in Trial. The High in Trial award does not take into account Handler Discrimination classes, even if offered at the trial. The High in Trial is determined by adding a team's faults across the elements. The team with the fewest faults will be declared High in Trial. If there is a tie based on faults, then the teams' times across the elements will be summed, and the faster-finishing team will win. If there is a tie after considering both faults and time, a coin-flip will determine the High in Trial. There shall be one High in Trial winner for each difficulty level offered.

Teams winning High In Trial will earn a medallion.

High in Combined Division

Teams who participate in the same difficulty level in all elements plus Handler Discrimination, and qualify in each, are eligible to win High Combined Division. The High Combined Division award is determined by adding a team's faults across all classes. The team with the fewest faults will be declared the winner of the High Combined Division. If there is a tie based on faults, then the teams' times across the classes will be summed, and the faster-finishing team will win. If there is a tie after considering both faults and time, a coin-flip will determine the High Combined Division winner. There shall be one High Combined Division winner for each difficulty level offered. The High Combined Division award is not recorded by the AKC.

Teams winning High In Trial will earn a medallion.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

REFUNDS

Refunds/credits will be issued within 10 days of the completion of the event.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded if a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Any entries pulled prior to pre-entry closing will be refunded minus any PayPal/Transaction fees. You must pull in writing (email or in person).

Any entries pulled after pre-entry closing will only be given a credit in the form of a voucher (minus a \$10 administrative fee per day plus any AKC/judge fees due) if there is:

- an entry on the waitlist that can take your spot (*refund issued minus admin fee and any transaction fees)
- an injury or other medical condition to the entered dog, in which case a veterinary note may be required
- a death or hospitalization of handler or an immediate family member, in which case a doctor's note may be required
- an emergency weather declaration (i.e. road closure due to weather, national weather emergency)

You must pull in writing (email or in person) before 7 am on the day of the trial.

If you wish to re-enter another day with your voucher you will pay the current entry fee rate.

TREAT VOUCHERS LIKE CASH. THEY WILL NOT BE REPLACED IF LOST.

Bitches in season will be refunded the full entry fee minus a \$10 per day processing fee and any payment transaction fees (i.e. PayPal fees). Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email.

Exhibitors MUST check-in EACH day they are entered.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.

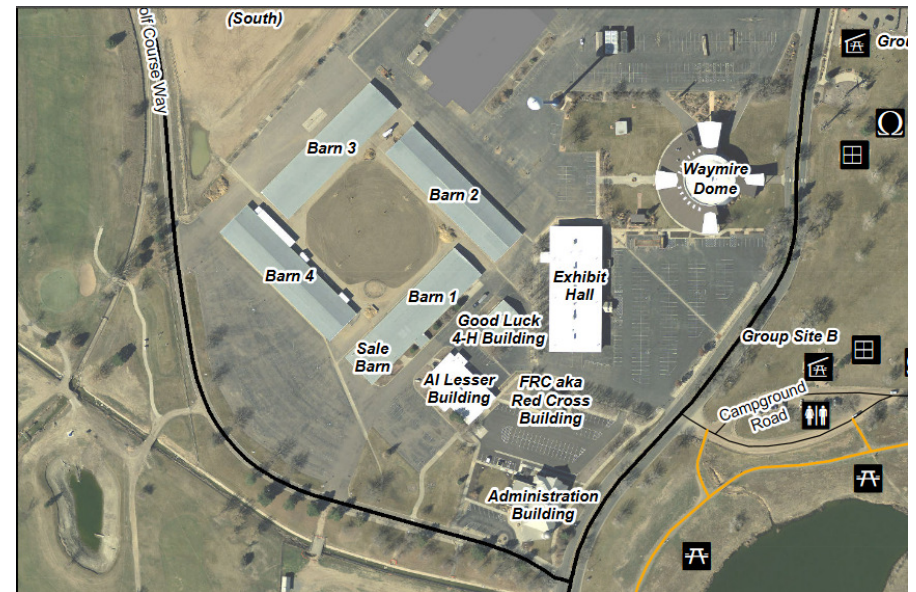
Local

Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and who have never worked as professional detection dogs. Novice B classes is open all dogs. Dogs may enter multiple dogs in different levels within each element (with the exception of Handler Discrimination), at each trial. Multiple dogs from the same owner may be entered in the same class/level, provided they are run by different handlers. Dogs entering the Advanced, Excellent, Master or Detective classes must have earned the required title, as stipulated in the AKC Scent Work Regulations. To be eligible for the High in Trial award you must be entered in all elements (Interior, Exterior, Buried, and Containers), in the same class, for that trial.
